The Insurance Profession

Everyone wants a challenging and financially rewarding career. Graduates of the insurance studies program have unlimited opportunities in the field of insurance. Many find positions as underwriters, claims adjusters, risk analysts, account executives, marketing representatives, and financial planners, to name a few. Insurance Studies at EKU

The insurance studies program offers a unique program of study. It is the only program offering a undergraduate degree in insurance in Kentucky. The program was created in 1976 as the result of the initiative of several Kentucky insurance business leaders who believed that the Commonwealth needed an insurance studies program to prepare young men and women for careers in the field of insurance. Such strong support has made it possible for the program to rapidly develop into a nationally recognized insurance studies program for undergraduate students. In the short history of the program, insurance majors at EKU have received national awards, internships, and scholarships. Equally important, students from the program have been successful in obtaining widely diversified positions in the insurance business upon graduation. Professionalism is required in today's business climate and our program provides the basis for achieving that competency.

Career Opportunities

Insurance majors at EKU are also encouraged to begin work toward such professional designations as the CPCU, CLU, ChFC, ARM, and AAI. Courses are offered in each semester that prepare students to take the national exams. Examination fees are reduced for full-time students. In many cases, insurance majors are reimbursed for their examination fees once they successfully complete the examination. Occasionally 'book' scholarships are available for courses associated with a professional exam.

The insurance business has also been cooperative in providing employment opportunities to insurance majors. This is an excellent way for students to earn money, get additional academic credit, and gain valuable experience.

Student Organizations

There are two active insurance organizations on campus -- The Insurance Society and Gamma Iota Sigma. The Insurance Society provides insurance majors with a variety of activities related to the insurance profession. In addition, students may also join Gamma Iota Sigma, which is the national insurance fraternity.

Insurance Scholarships

Various insurance organizations have been particularly helpful in making scholarships available for students in the program. Currently there are more than 14 scholarships awarded each semester to insurance majors. The scholarships range in amount from \$400 to full in-state tuition per academic year.

University requirements for: **Insurance (B.B.A.)**

Total Required Courses

University Requirements (1 hour)

BTO 100 (Academic Orientation).

General Education Requirements (36 hours)

Courses selected from Communication, Arts and Humanities, Natural Sciences, Social and Behavioral Sciences, Wellness, and Breadth and Depth of Knowledge.

Supporting Course Requirements (15-18 hrs)

Calculus or the combined courses of College Algebra and Managerial Decision Models, Introductory Sociology, Principles of Economics I and II; and Intro to CIS or Computer Literacy.

College Requirement: Professional Skills Seminar

BTS 300 (Juniors) and BTS 400 (Seniors)

Business Requirements (33 hours)

(Pre-Business Core) Introduction to Financial and Managerial Accounting, Legal and Ethical Environments of Business, and Business Statistics I.

(Business Core) Managerial Reports, Management Information Systems, Business Finance I, Principles of Management, Operations Management, Principles of Marketing, and Business Strategy.

Major Requirements (24 hours)

Principles of Risk and Insurance, Fundamentals of Property-Liability Insurance, Fundamentals of Life and Health Insurance, Risk Management, Insurance Company Operations, and nine hours of insurance electives to be selected from a listing of pre-approved courses.

Free Electives (16-19 hours)

Total Curriculum Requirements (128 hours)
